1. The initial page presents general information about Gamma Phi Delta Background Check.
2. Enter your full name and email address. Click **Continue - \$50.00**.
3. On the payment page, enter your payment information and click **Checkout**.
4. To register your account with Cornerstone Information Assurance, LTD (CIA), you must complete the necessary information and click **REGISTER**.
5. You will be invited by CIA – Gamma Phi Delta Sorority, Incorporated, to complete the background check information, which includes the following four (4) steps:
 - Create a password
 - Login
 - Review Legal Notices
 - Enter Personal Information
6. Once the profile is complete, a Summary and Confirmation page is provided.
 - You may need to click the “Proceed to Confirmation” button twice to receive the Summary and Confirmation page. **DO NOT** refresh this page.
 - If everything is correct, click **Submit**.
7. After completion, the applicant can check the status of their application using their Username and Password.
